In addition please be advised of the following informatives:

1. Please be advised that the details hereby approved relate solely to the area permitted under SW/10/774 (shown as land identified in red on drawing number 1A entitled 'Planning Application Boundary').
2. Please also be advised that all other conditions attached to permission reference SW/10/774 remain unchanged by this notice.

3. Please note the expiry date on your decision notice, along with all other conditions imposed. You are advised any conditions which require you to formally submit further details to the County Planning Authority for approval may be required to be formally discharged **prior** to commencement of operations on site, or within a specified time. It is your responsibility to ensure that such details are submitted. **Failure to do so may mean that any development carried out is unlawful** and which may ultimately result in the permission becoming incapable of being legally implemented. It is therefore strongly recommended that the required details be submitted to this Authority in good time so that they can be considered and approved at the appropriate time. **Note that from 6<sup>th</sup> May 2008 each submission of details pursuant to conditions attracts an application fee of £85**
