Progress since the last meeting

- 2019/20 plant availability was very good.
- 2020/21 plant availability is on target.
- Major planned boiler outage completed
- ELV compliance has been good.
- No lost time due to COVID-19





Plant Performance





Plant issues

- Plant has struggled with waste quality during the COVID pandemic. Increased quantities of non combustibles have been present in the waste.
- Plant suffered some issues with pressure part failures prior to the October outage.
- Since the outage the plant has suffered from some minor fuel handling issues.





Outage

We undertook a major outage in October:

- Major Steam Turbine Overhaul This is the first time the turbine has been opened since 2013. Major components were sent off-site for detailed cleaning and inspection.
- Boiler 2 had significant refit with the replacement of 344 tube sections and Inconel overlay applied to various sections of tube.
- Steeplejacks were used to inspect and re-paint the main chimney stack and that of the odour abatement plant
- Conveyors on the fuel handling system had wear parts replaced in some cases this included new belts and chains
- Both boilers had significant attention on bottom ash conveying screws to address excessive wear that led to ash-handling issues and downtime prior to the outage.
- At the Flue Gas Treatment plant all 672 filter bags on boiler 2 were replaced. In addition, the old mild steel support cages for each filter bag was replaced with stainless steel
- The cooling tower was thoroughly cleaned and disinfected in order to comply with legionella control legislation in addition to timber repairs within the cooling tower

COVID-19

- Kitchen/Canteens:-doors/handles (including fridge/cupboards), switches, sockets, all dispensers, all worktops, sinks, taps, microwave.

To facilitate the above measures

- · Single use of disposable cloths
- Single use of disposable gloves
- Use sanitising fluid supplied

Particulars of Development: Application under Section 42 of the Town and Country Planning (Scotland) Act 1997 (as amended) for permission to vary, Condition 17 of Planning Permission 16/00916/FULM to allow for parallel operations of both facilities for a period of up to 10 years.

Site Location: Land At Forties Road, Baldovie Industrial Estate, Dundee, DD4 0NS

Notice is hereby given that Dundee City Council has GRANTED planning permission for the above development as described in the application and the plans accompanying the application, subject to any conditions attached to this consent :

Condition(s):

- Prior to the commencement of any works on site details of a scheme of public art to be provided within the development hereby approved shall be submitted to the Council for written approval. Thereafter, the approved scheme of public art shall be installed prior to the completion of the development hereby approved.
- Prior to the commencement of any works on site, a Sustainability Statement demonstrating the extent to which the development will meet the requirements of Policy 48 of the adopted Dundee Local Development Plan (2019) shall be submitted for the approval of the Council and the works shall be completed in accordance with the approved Statement.
- 3. Prior to the operation of the development hereby approved, removal of the Invasive Non-Native Species (INNS) Giant Hogweed and Himalayan balsam (referred to as Indian balsam in ES vol.2) shall be undertaken in line with the NetRegs best practice guidance. The INNS shall be replaced with suitable species (in consultation with SNH) so as not to leave bare ground and an ongoing maintenance plan shall be provided, for the prior approval of Dundee City Council as planning authority.
- 4. Prior to the operation of the development hereby approved, further details with regard to ecological enhancement as recommended within the Environmental Statement hereby approved shall be agreed with Dundee City Council in relation to the planting of native berry-bearing species and creation of kingfisher burrows along the banks of the Dighty. Thereafter the agreed details shall be fully implemented.
- 5. Prior to the commencement of any works on site, further details shall be submitted for the design of the compensatory storage area, to be developed in line with the Flood Risk Assessment dated 13 December 2016. No building shall take place within the compensatory storage area. Thereafter these details shall be fully implemented.

Environmental Update 4th Quarter 2020 (October – December)

- No complaints reported to site or SEPA during Q4 2020
- One environmental incident was raised on site due to a very minor diesel spillage from a contractors generator during our major outage period
- Four CO exceedances were reported to SEPA during Q4 2020, all exceedances are related to restarting waste firing





MEB Odour Management

- Continuous quarterly odour stack analysis reporting already conducted under permit compliance
- Additional odour sniff test was conducted with results concluding there is a waste smell but inconclusive due to the surrounding area and our Waste Transfer Station (WTS)
- The WTS is to fully cease operations resulting in all MEB waste being stored within confined buildings
- Q1 smoke test planned for building integrity with 150k budget for any repair or maintenance allocated
