COVID -19 update

Social distancing rules are being maintained with shift working patterns being implemented to reduce staff contact. No reported staff illness due to Covid-19

MM – see attached appendix on community benefits activities.

- MEB is working in partnership with Angus Council, DYW and DC Thomson to launch a comic book strip competition for pupils in Angus Council
- 2000 copies of the Hot Commissioning notice were distributed within a radius of 1km
- MEB Challenge Fund to reopen in August 2021 due to Covid-19
- MEB worked in partnership with Founder 4 Schools at their spotlight on careers event
- In the first quarter of the year, there have been 4 vacancies advertised on the Courier and shared with the Job centre
- Due to Covid-19, all site visits were halted in line with the government regulations

SA – queried the impact of the new legislation on the smoke detectors and the effect on MEB

- JC confirmed that it is an issue that MEB and the councils are aware of and have regular meetings to discuss including the presence of mobile phones and batteries in residual waste.
- AS said, he has not yet seen smoke detectors in the current facility however the percentage that would get to MEB would be negligible as the majority of the replaced alarms would end up in commercial waste streams.

JM queried if there was an increase in the quantity of plastics in the waste

#### **Progress since the last meeting**

- 2020/21 plant availability is on target.
- Minjor planned boiler outage completed
- ELV compliance has been good.
- No lost time due to COVID-19

### **Plant issues**

- Lines 1&2 struggled with waste quality during the COVID pandemic. Increased quantities of non combustibles were present in the waste.
- Since the spring outage, the plant has suffered very few issues.





# Outage

We undertook a minor outage in March:

- Both boilers had superheaters dry-rodded and economisers were cleaned with high pressure water jetting
- Flue gas treatment plant on both lines were cleaned and inspected.
- Cooling Tower Clean and Inspection. Disinfection and cleaning routines completed as per statutory control arrangements for legionella.
- Refractory was installed over 4m2 of internal boiler wall and roof where thin tubes were identified to prolong tube life and prevent tube leaks until a planned replacement (in planning for Autumn outage)
- 12 blowdown valves were replaced on boiler 1 to reduce leakage.
- Statutory pressure system inspections were completed throughout the compressed air system and working examinations were completed on both boilers following the outage.
- Significant hard-facing work was completed on the SID shredder and North reclaimer screw.
- ✓ Fuel chutes were inspected and reinforced
- Conveyor wear parts were replaced





### Fire

- Here at MEB we have been seeing a higher number of small fires than we have historically.
- This is not just an issue affecting MEB as we have seen with the weekend's fire at NWH.
- This is an industry wide problem as was recently covered in the BBC
- We recently suffered a fire at our waste transfer station after what we suspect was a large container of petrol went through the shedder. The photo attached shows the incident 8 minutes in just before the site team get it under control. The fire service arrive 3 minutes later.



The stress levels rocketed for Ian Scott-Browne earlier this month, when one of his colleagues radioed him and told him to call the fire brigade.

## COVID-19

- MEB very early adopted a robust strategy of social distancing to mitigate against the threat of COVID-19 to our staff.
- We were assisted with some medical guidance from one of our company doctors (Dr Hölzel)
- Social distancing was in place throughout the planned outage
- The site team are becoming very adept at using all of the video calling platforms even using them for staff interviews and contractor safety meetings.

#### Environmental Update 1st Quarter 2021 (January – March)

- No complaints reported to site or SEPA during Q1 2021
- One environmental incident was raised on site due our MSW Hall roller door being damaged potential releasing odour into the atmosphere, SEPA were informed, and repair conducted.
- There have been no emission limit value exceedances during Q1 2021.
- MEB have agreed to submit a joint Scottish EfW response to SEPA on the forthcoming BATREF implementation.





### MEB Noise Management 2021

- 6 noise complaints have been received to the site relating to the turbine bypass.
- Internal investigations have pinpointed this area with SEPA in communication.
- Control measures have been implemented to reduce to the steam flow from 45 tonnes per hour to 30 tonnes per hour during silent hours an external noise.
- Consultant has been commissioned to identify the source of the noise to provide evidence to our contractor and to implement a long-term corrective action.







## **MEB Fire Management 2021**

- There was a fire at our waste transfer station on the 18/04/2021 that is managed under a Waste Management License with SEPA informed
- This fire was very quickly brought under control by our onsite team to hand over to the Scottish Fire & Rescue Service helping to prevent a serious incident.
- Unfortunately, there has been 4 known fire within the waste industry in Scotland that can be attributed to lithium-ion batteries within the waste stream.
