

Work is on-going to complete the air-cooling condensers SPG, an SBG subcontractor, will carry out works between Christmas and New Year The roof cladding has been finalised Due to high winds and Christmas holidays, the tower crane will be dismantled on 6th and 7th January

	 The following civils work have been completed; tipping hall slab protection, machine house roofing works, north and south elevation cladding, boiler house roofing works and the structural steelwork for the tipping hall SBG held a boiler stamping ceremony PL stated construction is on schedule with commissioning set to begin in spring PL confirmed advanced notices will be distributed to the local community about steam blowing MM – see attached appendix on community benefits activities. MEB is currently recruiting with the job adverts in the Courier The LOCHER project has won either 1st or 2nd prize in both categories for innovation and development through education for the safety posters and leaflets. In pursuance of MEB's ethos to positively integrate within the local community and enhance its positive impact to the environment, we will be seeking volunteers who would be willing to record instances of bad odour which can be attributed to our facility. AMel affirmed that odour emissions from the facility had improved by 99.9% since MEB took over operations MEB held a series of 1-hour long educational tours of the facility for local businesses and members of the community dubbed 'Meet your Waste' event from 2nd – 5th December. This event was very successful with a total of 304 people coming to visit our facility


Progress since the last meeting

What an experience - Here at Kwinana Beach, Western Australia. I had the opportunity today to visit Australia very first EfW thermal process plant with Operations Director, Alan Jones.

Acciona providing civil EPC package while Belgium based Keppel Seghers will be providing the mechanical process.

Once fully operational in 2021, the plant will process up to 25% of Perth's post recycling rubbish (400,000 TPA) providing 36MWe to the grid, in turn meeting up to 50,000 household electrical needs.
